(per C.R.S. 1-13.5-303)

Deadline for Self-Nomination Forms: Self-nomination and acceptance forms must be filed not less than 67 days before the date of the regular election. (The self-nomination deadline for the 2027 regular election is February 26, 2027, no later than 5:00 p.m.)

Such Notices shall remain posted until the Tuesday succeeding the first Monday of the following May.
